# **BIOGRAPHICAL INFORMATION**

Fabienne Hara served as the Vice-President for Multilateral Affairs of International Crisis Group from February 2008 to October 2013, overseeing Crisis Group's advocacy and research at the United Nations and the Security Council in New York, and directing the Crisis Group New York office. She has over twenty years of experience in conflict management and resolution issues, African affairs and multilateralism, topics on which she has published extensively. Prior to joining Crisis Group as a Vice-President, she served as Acting/Deputy Political Chief of the United Nations Mission in Sudan (2006- 2007). She was previously a Senior Political Officer in Department of Political Affairs at the UN and a Fellow at the Carr Center for Human Rights Policy, Harvard Kennedy School of Government (2005). Between 1998 and 2003, she was the first Director of the Africa Program at Crisis Group. Ms. Hara also served as the Great Lakes Project Coordinator at the Center for Preventive Action of the Council on Foreign Relations (1996-1997) and as a Team Leader for Doctors of the World in Burundi (1995).





Fabienne Hara holds a Postgraduate degree in International Relations and an M.A in Political Science and International Relations, both from the Institut d'Etudes Politiques de Paris (1991-1994), as well as an M.A in German Studies and an undergraduate Degree in French Literature.
